

Kimberty-Clark Professional™ KleenGuard™ A80 Chemical Permeation & Jet Liquid Protective Coveralls, constructed using an orange barrier film/non-woven laminate with welded seams & elastication at cuffs, hood, ankles and waist, which are available in six nominal sizes. Product codes: 9650 to 9655 inclusive (global codes 49651 – 49655 inclusive).

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC. When examined the PPE satisfied the relevant requirements of the harmonized standards:

EN 1073-2:2002 (non-ventilated protective clothing against particulate radioactive contamination) for a performance classification of TIL Class 1;
EN 14605:2005 (Type 3 Limited life, full body chemical protective clothing with liquid tight connections);
